Wash skin thoroughly with soap and water or use recognized skin cleanser. Do NOT use solvents or thinners.

After Eye contact: Irrigate copiously with clean, fresh water for at least 10 minutes, holding the eyelids apart. Remove contact lenses. Seek medical advice.
Have emergency eye-washer in workplace

After Ingestion: If accidentally swallowed obtain immediate medical attention.
Keep at rest.
Do not induce vomiting.

5. FIRE-FIGHTING MEASURES

Suitable extinguishing media: Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide.

Extinguishing media which must not be used for safety reasons: Do NOT use water jet.

Handling
